



Gloucestershire Wildlife Trust prize draw terms and conditions

These terms and conditions govern the Gloucestershire Wildlife Trust (GWT) prize draw. The competition organisers are the GWT. By accepting the terms and conditions of the competition, you will be entering into an agreement with the organisers.

1 Competition entry

By entering the competition, you agree to the provisions of these terms and conditions and to comply fully with them.

A maximum of one entry per individual is permitted. The prize draw is free to enter.

2 Eligibility

Unless otherwise stated, our prize draws and competitions are open to all except employees of Gloucestershire Wildlife Trust, their families, agents or any third party directly associated with administration of the prize draw.

In entering the prize draw, you confirm that you are eligible to do so and eligible to claim any prize you may win.

If you are under the age of 18 you must have consent to enter from your parent or guardian. By submitting an entry for the competition, your parent or guardian is deemed to have given such consent and to agree to the use of the entry as described in these terms and conditions.

Those in doubt as to their eligibility must contact the organisers for clarification before entering. The organiser's decision on eligibility is final.

3 How to enter

The competition closes on Friday 31 May 2024 at 5pm.

To enter the prize draw complete the form displayed to you at the event, or by using the QR code.

GWT will not accept responsibility if contact details provided are incomplete or inaccurate.

5 The prizes

The prize will be as follows: a goody bag from Gloucester Services. The goody bag includes ID cards / books, local honey, jam and apple juice and other food items. This prize is family friendly.

GWT reserves the right to substitute prizes with another prize of equal or higher value if circumstances beyond our control make it necessary to do so.

The prize will be sent to the winner within 14 days of responding to GWT.

The prize is non-exchangeable, non-transferable and no cash alternative is offered.

Gloucestershire Wildlife Trust reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.

The decision of the organisers is final, and no correspondence will be entered into prize draw judging and organisation.

6 Announcement of winners

A winner will be chosen by random draw performed by a computer process within one month of the prize draw ending.

The winners will be contacted via telephone or email within seven days of being selected, using the detail inputted when entering this prize draw.

GWT will attempt to contact winners by email up to two times. If contact is not made within 14 days of being notified, GWT reserves the right to select and notify a new winner.

9 Data protection
