

GLOUCESTERSHIRE WILDLIFE TRUST AGM MINUTES

Minutes of the Sixtieth-First Annual General Meeting held electronically on Thursday 17th November 2022.

1. Introduction

Ally Wilson, Director of Engagement and Fundraising, welcomed members to the Trust's virtual Annual General Meeting. Ally explained the house-keeping arrangements including the mechanisms for raising questions, voting and for seeking technical assistance during the meeting.

2. The Chair's opening remarks

David Bullock, Chair of the Board of Trustees, welcomed all members to the Annual General Meeting and thanked them for attending. He thanked staff, volunteers, members and funders for their continued support.

The Chair noted several achievements from the year many of which are outlined in the 2021/22 Impact Report:

- Launch of the 2030 Strategy.
- Implementation of the Estate Review.
- Completion of two large projects based on connecting people with nature: Our Bright Future and Foresters' Forest.

3. Approval of the minutes of the Sixtieth Annual General Meeting held on 6th November, 2021

The minutes of the Sixtieth Annual General Meeting held on Saturday 6th November 2021 were approved.

5. Adoption of the Sixty-first Annual Report for the year 2021-2022

The Sixty-first Annual Report for the year 2021-2022 was adopted.

6. Adoption of the Accounts for the year ended 31st March 2022

David Jones, Chair of the Trust's Finance and Remuneration Committee, summarised the accounts and presented highlights for the year to 31st March 2022:

- Total income grew by 2% from £4.8m last year to £4.9m this year.
- Total expenditure during the year increased by 24% from £3.5m to £4.4m
- After a net loss on investments of £155k the Trust's net income for the year was £300k.
- At the end of the financial year, the Trust maintained emergency reserves at £650k and held £1.1m of funds for restricted commitments plus £405k of unrestricted funds.
- The net assets of the Trust increased from £6.8m to £7.1m
- Our commercial subsidiary, Gloucestershire Wildlife Enterprises Limited had a successful year.
- The Trust had over 28,000 members in March of this year, an increase of more than 1,000 since last year and membership income grew to £1.2m.
- Over 500 volunteers contributed nearly 40,000 working hours for the benefit of the Trust. This was worth the equivalent of over £500k.

Special thanks were again due to Grundon Waste Management, the Trust's largest corporate sponsor, who contributed during the year through the Landfill Communities Fund.

The Accounts for the year ended 31st March 2022 were adopted.

7. **Appointment of Auditors for 2022/2023**

It was noted that auditors are reviewed regularly on the basis of their capability and value for money. Godfrey Wilson Limited had been the Trust's auditors for the last few years and they did a good job again this year and their fees are reasonable for the work they undertake.

Godfrey Wilson Limited were appointed as auditors for 2022/2023.

9. Review of the year and plans for the future

The Review of the Year included presentations on the Wild Trainees, Foresters' Forest and Rainscapes projects.

Roger Mortlock, Chief Executive, outlined the Trust's plans for the future underpinned by 10 Nature Recovery Zones, Activities include the launch of the Severn Treescapes project, the Eelscapes project in partnership with the Wildfowl and Wetlands Trust, and plans for the creation of a 40 hectare Nature Park along the River Severn in Gloucester.

Roger thanked volunteers who continue to support the Trust across all areas of our work.

10. **General Questions**

Ally Wilson hosted a session which answered the questions that had been raised during the meeting via the Q&A facility. Questions were answered on the Defend Nature campaign, GWT's investments, the impacts of ash dieback on GWT's nature reserves, and the wilding of hedgerows.

11. Chair's closing remarks

The Chair introduced the three new Trustees and then closed the formal section of the AGM.
